- No labor charge for any discounted part replacement (except air handlers);
- No service diagnostic fee for any normal and after hours visits.

Standard Water Heater Plan, \$179.95, plus tax* per year (excludes tankless water heaters)

The **Standard Water Heater Plan** includes an annual tune-up of your water heater, burner replacement parts, aquastat controls, relief valve and emergency switch. Replacement of hot water tank is not included in this coverage.

Terms & Conditions Apply To All Contract Types

1.) **Size & Type of Units Covered**

These heating plans are designed for oil and propane equipment burning up to 3 gallons per hour or running on natural gas. All plans are not available for the following heating units: Lennox Pulse furnaces & Buderus Blue-Flame boilers.

2.) **Inspection and Service**

Leahy's reserves the right to inspect equipment prior to acceptance. We do this to ensure that your equipment is working properly or is made to work properly so that both parties are aware of the equipment's condition at the time of plan acceptance. Repairs required before plan acceptance will be billed at prevailing rates. We reserve the exclusive right to reject an oil or gas fired unit from coverage under this plan prior to issuing or renewing this agreement. Inspections (including flue pipe), tune-ups, and required services are subject to the accessibility of equipment and the availability of parts from normal supply sources. All parts listed under this agreement which are eligible for replacement will be replaced with equivalent parts. Repair or replacement of parts which are not available through regular sources of supply and/or require upgrade are not covered and will be charged at prevailing rates. Obsolete parts are not covered. Annual inspection and tune-ups will be performed during regular business hours. Leahy's will not be responsible for tune-ups, inspections, or services not performed due to the unavailability of customer to schedule work. All service will be performed providing the safety of our technicians is not compromised. The condition and maintenance of the chimney and flue are the responsibility of the homeowner.

3.) **Purchase of Fuel/Cancellation**

The customer agrees that during the term of any offered contract plan, and renewal thereof, service calls related to quality of fuel not purchased from Leahy's will be billable. The customer agrees to keep their accounts current at all times. The plan will be cancelled in the event the customer breaches this agreement or that a Leahy's representative determines that continued operation of the equipment may pose a health or safety risk. In the event of cancellation, refunds (if any) will be prorated on the full months remaining on the plan less any services rendered prior to cancellation.

4.) **Renewal**

This plan will automatically renew from year to year on the anniversary date, unless you cancel the plan. The anniversary date refers to the date of Leahy's acceptance of this plan.

Terms & Conditions Continued

5.) Exclusions

The following acts or conditions are specifically excluded from this plan because they are not related to maintenance service. Any work performed due to these conditions will be billed at our prevailing rates.

- Leaking, frozen, or congealed oil lines or tanks;
- Issues related to fuel quality from another supplier;
- Coverage to unattended properties or damages from heat failure for any reason;
- Electrical or plumbing work beyond immediate unit;
- Addition of components or replacement of entire system;
- Repeated pump-out of water in storage tanks;
- Owner/Operator errors or omissions;
- Damage due to water and/or flooding, acts of God, tampering, abuse, or other causes beyond our control;
- Labor relating to the installation of parts not covered by your contract will be billed at prevailing rates.
- Damage from leaking propane or oil lines or customer-owned tanks;
- Damage due to attempts to service equipment by person(s), including owners, unless instructed by our service department;
- Contracts do not cover relocation, upgrade or replacement of equipment.
- Steam system low water cutoffs are tested and flushed during the annual tune-up. Leahy's assumes no responsibility for damage resulting from the failure of this control and recommends an adequate water level be maintained at all times and that it be flushed periodically by the owner.

Heating system antifreeze replenishment or replacement is not covered. Component replacement due to corrosion by antifreeze is not covered.

6.) Limitations of Liability

Leahy's shall not be liable for injury or damage to persons or property resulting in defects in, or non-operation of, customer's heating equipment, its accessories, or damages resulting from equipment failure. Leahy's will not be held responsible for modifying or replacing equipment that fails to heat any structure due to improper system design or improperly-sized equipment.

The customer shall be responsible for the condition and maintenance of the fuel tank, lines, and piping. Leahy's assumes no liability for same. This service plan does not insure against tank leakage or any damages to persons or property resulting from tank or oil line leakage. This service plan does not cover any installation, cleanup, removal, remediation, or other cost of compliance with any environmental or other laws, rules, or regulations. Tank repair and replacement shall be billed at prevailing rates at the time of repair or replacement.

Leahy's assumes no liability for any damage to a home unattended for 24 hours. This includes damage to homes of automatic delivery or will-call customers due to no-heat conditions as a result of equipment failure and/or out-of-fuel conditions.

7.) Entire Agreement

This agreement contains the entire agreement of the parties hereto, and there are no promises, terms, conditions or obligations other than printed herein.

8.) Service Hours

During the life of this agreement, Leahy's Fuels, Inc. will provide dependable, prompt emergency service 24 hours a day, 7 days a week, 365 days a year. Emergency service is available after normal working hours for the following: **NO HEAT, SERIOUS FUEL LEAKS OR DANGEROUS SITUATIONS.** All other regular service will be performed during normal working hours, Monday through Friday, 8 a.m. to 4 p.m., except Holidays.
